CPS GUILD FOR VOLUNTEER DRIVERS

Volunteer drivers include administration, teachers, coaches and parents. Anyone driving students to a school activity in a school owned vehicle, **or** personal vehicle.

Volunteer drivers must be at least 21 years of age.

Volunteer drivers must fill out the **Volunteer Driver Information Sheet** and have it turned into the Transportation Supervisor **24 hours in advance** to drive to an activity.

Parent volunteers will only be on the list for a year. For that reason, they will need to fill out a form each year. [Perhaps at the beginning of a seasons parent's meeting would be a good time to catch parents that may drive]

Staff will be kept on the list and checked on occasion. If an issue arises and a staff member is in question as to if they are eligible to drive students, contact the Transportation Supervisor, or just don't drive.

Volunteer driver will not smoke in vehicle.

Volunteer drivers will not consume alcohol or drugs that might impair judgment.

Volunteer drivers will follow all traffic laws and drive to weather conditions.

Non-staff volunteer drivers will also need to fill out the Rayderaid Volunteer Form and send it to Central office for approval.
